District—Larut. Mukim—Asam Kumbang. O.S. Plan—16-13. Lot—No 347. Area 3 acres, 2 roods and 1 pole.

Boundaries—Commencing at the north-eastern corner of Agricultural Lot No 126, boundary extends eastwardly along the southern boundary of Mining Lot No. 565 to north-western corner of Agricultural Lot No. 113; thence southwardly along the west boundary of the said lot to the south-western corner thereof; thence by bearing 293-290-29, 291-11, and distance 149 links, 147 links and 139 links, respectively, to the south-eastern corner of the Agricultural Lot No. 126; thence northwardly along the eastern boundary of the said lot to the north-eastern corner thereof; the point of commencement.

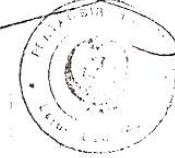
